## A Guide on How to obtain Free School Meals





#### What are Free School Meals?

A Free School Meal is a school lunch provided free of charge by Aberdeenshire Council to children whose families meet the required criteria.

In addition, since January 2015 all Primary 1 to primary Primary 3 pupils have the option to take a free school meal every day. School children receive the same school meal as a paying pupil which is chosen through the interactive menu process within the classroom.

In a **Secondary School**: The child/children receive a daily credit allowance in the schools cafeteria to be used at lunchtime, equivalent to the value of a two-course meal on items chosen off the menu. Further details are available from your child's / children's School Office.

### Is my child entitled to a Free School Meal?

Free School Meals are linked to the level of benefit / income a family receives and will be provided if :-

- a family is in receipt of Income Support or Pension Credit. (Guarantee Credit)
- a family is in receipt of Job Seekers Allowance (Income-Based) or Income related Employment Support Allowance.
- a parent is receiving Child Tax Credit (CTC) but not Working Tax Credit and your annual income is less than £16,105\*.
- a parent is receiving Child Tax Credit and Working Tax Credit and their annual income is less than £6420\*.
- parents receive help under the Immigration and Asylum Act 1999.
- any person between the age of 16 to 18 years old in receipt of any of the benefits listed above is eligible to claim Free School Meals.
- parents receive Universal Credit

## Where can I obtain an Application Form from?

You can request an application form by calling the Benefits Section on 03456 08 12 00. Application forms are also available at your child's/children's school.

Please note, if you apply for Housing Benefit/Council Tax Reduction, the application form will also be used to claim for free school meals – you will not be required to complete a separate form. If your child is entitled to free school meals, the Benefits Section will send you a letter confirming this. You can take this letter to the school to claim your free school meals.

If you are not claiming Housing Benefit/Council Tax Reduction, the Benefits Section will also assess your entitlement to free school meals.

# Do I have to provide any additional information along with my Application Form?

Proof of income <u>must be produced</u> along with the completed application form.

This can either be: -

- TC602 Tax Credit Award Notice for 2015/2016 from the Inland Revenue showing entitlement to Tax Credits.
- A letter from the Department for Works and Pensions (DWP) confirming your entitlement to benefit.
- Confirmation of support from the National Asylum Support Service.
- \* These figures are subject to change from the Inland Revenue but are correct at present.

## Who do I return the Application Form to?

Application Forms must be returned to; Aberdeenshire Council, PO Box 18533, Inverurie, AB51 5WX

You can also return the form to your local Benefits office.

## What happens if my circumstances change?

If your circumstances change for any reason you must advise the Benefits Section immediately, by calling 03456 08 12 00 or by E-mail at benefits@aberdeehshire.gov.uk.

If you receive a Free School Meal which you are not entitled to, you will be required to pay back that money.

### It is your right to make an application if you meet any of the criteria.

Aberdeenshire Council encourages ALL Parents of pupils who qualify, to apply for Free School Meals.
